



**SPECIAL TERMS AND CONDITIONS FOR A GUARANTEED INVESTMENT IN
Equity-Hedge SMART PORTFOLIO®**

These Special Terms and Conditions (these “**Special Conditions**”) supplement the customer documentation of the applicable eToro Entity (as defined below) available on our [website](#) (“**Terms and Conditions**”). These Special Conditions set out the terms under which you can invest in a Principal Guaranteed Equity-Hedge Smart Portfolio® (applicable to Equity-HedgeUSD, Equity-HedgeEUR, and Equity-HedgeGBP) (Principal Guaranteed Smart Portfolio or “**PG Smart Portfolio**” and the foregoing offer, the “**Promotion**”). In case of conflict between these Special Conditions and our Terms and Conditions, these Special Conditions will prevail. All capitalized terms used herein and not otherwise defined shall bear the meaning ascribed to them in the Terms and Conditions. For the purpose of this Promotion, the “**eToro Entity**” shall mean the eToro entity from which you receive brokerage services which can be either eToro (Europe) Ltd., eToro (UK) Ltd., eToro (Seychelles) Limited or eToro (ME) Limited.

Please note:

There is the possibility of the occurrence of a market disruption or other event beyond our reasonable control which has or will have a material adverse effect on our ability to manage the related risk, or to otherwise perform our obligations under these Special Conditions. If such an event occurs, we may, acting reasonably, take such action as we deem necessary, including (without limitation) advancing or delaying cashing of the Guaranteed Amount. The Guaranteed Amount is calculated, denominated and applied exclusively in United States Dollars (USD). Any non-USD currency values displayed on the platform are for display purposes only.

- Upon submission and acceptance of the T&C via the platform, this Promotion shall form a legally binding contract on your part.

1. **Promoter Details.** These Special Conditions are made by the following eToro Entities, each solely with respect to its direct clients and not on behalf of the other entity:
 - 1.1. eToro (Europe) Limited, a limited liability company incorporated in Cyprus (registered number HE 200585), authorized and regulated by the Cyprus Securities and Exchange Commission under a CIF license No. 109/10.
 - 1.2. eToro (UK) Ltd., a Financial Services Company authorized and regulated by the Financial Conduct Authority (FCA) under the license FRN 583263.
 - 1.3. eToro (Seychelles) Limited, a Securities Dealer holding a Securities Dealer Licence under the Seychelles Securities Act, 2007 (licence number SD076).
 - 1.4. eToro (ME) Limited, a limited liability company incorporated in the United Arab Emirates authorized and regulated by the Financial Services Regulatory Authority (FSRA) with reference number FSRA 220073.
2. **Eligibility.** The Promotion is limited to the Minimum and Maximum Investment amounts, invested in the PG Smart Portfolio during the Investment Period, per each account person/household or environment in which computers are shared. Users participating who have more than one trading account will be eligible only once. Users opening or operating multiple accounts in order to participate in this Promotion will not be eligible under this Promotion. Users from the countries listed in Annex A below and such other jurisdictions in which we do not provide services as provided under the Terms and Conditions, cannot participate in this Promotion. This Promotion shall only be available to users whom we have assessed to be suitable to engage in copy trading. 3. **Principal Guarantee Protection.** Subject to the following: (i) fulfillment of all the eligibility pre-conditions set forth herein, (ii) full compliance with these Special Conditions, and (iii) full compliance with the Terms and Conditions, eToro shall, immediately upon you making a qualifying investment, provide you with a guarantee which applies from the date you invest in respect of the amount, with a fixed minimum balance of your qualifying investment (**Guaranteed Amount**). This guarantee:
 - 3.1. is subject to terms and conditions (set out in this clause 3) that applies to amounts withdrawn at the end or after the Expiration Date; and
 - 3.2. accordingly involves a benefit that is lost if and when you withdraw the amount prior to the Expiration Date. For the avoidance of doubt, the benefit referred to in this clause 3.2 is the Principal Guarantee Protection only. If you withdraw prior to the Expiration Date, you remain entitled to the actual value of your investment at the time of withdrawal (whether higher or lower than the Guaranteed Amount); only your entitlement to the Principal Guarantee Protection is forfeited.

calculated, denominated, and applied exclusively in USD. To the extent the value of your investment is expressed or converted into a currency other than USD, you assume all risks associated with foreign exchange rate fluctuations, and eToro shall have no obligation with respect to any such non-USD valuation.
