

Terms & Conditions

eToro Bonus Offer

Last update: March 30, 2020

eToro USA LLC (“eToro” or “We”) will provide a bonus of US \$200 to invited participants who fund their existing eToro account and initiate a trade of \$2,000 or more between April 8, 2020 and April 28, 2020 (the “Promotion Term”), provided that the qualifying terms below have been met (“Bonus”).
